

RESTRICTED ITEMS LIST/ CONTRABAND

Items that present a safety risk or harm to patients. The following items are banned from patient use due to safety concerns, health concerns, value and confidentiality issues.

- Any Items Restricted by Law
- Alcohol, Drugs and Drug Paraphernalia
- Weapons including Knives, Guns and Ammunition
- Matches, Lighters, Smoking Materials, Tobacco Products and smokeless tobacco products including E-Cigarettes
- Office/School Supplies Brought From Home (Supplies will be provided by the Center for offered activities):
 - Scissors
 - Spiral Notebooks
 - Staples and pencil sharpeners
 - Pens or Mechanical Pencils
 - Whiteout
- Sharps and Needles of any kind including scissors, knives, razors, nail clippers or metal nail files, safety/ stick pins, knitting needles, tacks, keys or paperclips
- Inappropriate Clothing:
 - Items with Advertisement of Drugs and Alcohol
 - Clothing that is Torn
 - Clothing that is revealing or imprinted with inappropriate messages on drugs/alcohol or disrespectful to others
 - Provocative/ Revealing Clothing, including but not limited to: Hot Pants, Short Shorts, Tank Tops, High Heeled Shoes
 - Steel Toe Shoes
 - Shoe Laces, Suspenders, Belts, Scarves, Ties, Pantyhose, Stockings, Elastic Socks and Clothing with strings that are detachable (i.e. Draw-string Pants or Hooded Clothing Items, however the hooded sweatshirt may be worn once the string(s) are removed)
- Electrical Items:
 - Televisions
 - Radio/Stereo with Electrical Cord
 - Alarm Clocks with Cords
 - Heating Pads/Electrical Blankets/Mattress Pads
 - Electrical Appliances with a cord
 - Clothing Iron
 - Vaporizer/Humidifier
- Cellular Phones**(use for retrieval of contact numbers only)
- Pagers and Cameras and any other device that can capture picture or video
- Personal Hygiene/Grooming Items:
 - Talcum Powder
 - Shower Scrunchies
 - Mouth Wash with Alcohol
- Latex Balloons
- Food and Beverages, including Candy and Gum
- Plastic Bags
- Candles or Incense
- Inappropriate reading material or viewing materials or media with a rating higher than PG-13
- Aerosol Cans
- Glass Picture Frames or Vases
- Purses or Bags with Straps
- String of any kind
- Elastic Bands including but not limited to hair bands, Hair ties with metal clip, exercise bands
- Medications
- Collectable Cards
- Metal or Wire Hangers
- Sporting Equipment/Items
- Clothing/Hamper Bag
- Credit Cards, Money and/or other Valuables – may be placed in the Security Office

SAFETY ITEMS

Items that present a potential safety risk to patients. The following items can be allowed for patient use at the discretion of staff based on individual safety risk. Some items may need an order from a physician for use by the patient.

- Electronics
 - Hair Dryers
 - Curling Irons
 - Battery (AA batteries) Operated Clock Radio
 - Other Electronic Devices**
 - Shaving Razors
 - Shower Scrunchies
 - Pens or Mechanical Pencils
 - Jewelry will be assessed for safety by the Treatment Team
 - Laptop Computers (may be used during assigned time only) **-
 - Dental Floss (6-8 inches per sign out)
 - Compact Make-Up Kits
 - Art Items/Craft Items**
 - Grooming and Hygiene supplies with potentially dangerous container/package
 - Mouth Wash without Alcohol
 - Toothpaste
 - Shampoo
 - Musical Instruments**
 - De-stimulation devices- Head phones, Digital music players, hand held video games** Electronics including video games, CD Players, MP3 Players, Walk-Man, I-Pod, etc.
 - Physician Ordered Medical Devices (i. e. CPAP)
- ** Must be used in open area at staff's discretion
