Information to Expedite the Admission Process

 Criteria for admission of pregnant and post-partum patients: No limit on the time between delivery and post-partum to admit. Patients under the care of an obstetrician, primary care physician who provides obstetrical care, or certified nurse midwife can be accepted in the first and second trimester without any known complications. The patient must be in agreement that she will be transferred to the nearest local hospital (West Chester Hospital) if obstetrical issues arise, and not to the hospital where the delivery is planned. This includes any Doppler readings required. No gynecological exams can be completed/required for current pregnant or post-partum patients. No level of wound care for post-partum patients will be provided. Only standard labs will be ordered. Post-partum patients may pump breast milk which will then be labeled and stored in a special freezer on the adult inpatient unit. Post-partum patients may be responsible for bringing their own specialized supplies.
Insurance for hospitalization and other hospital-based services: In general, Lindner Center of HOPE accepts payment from major insurance carriers for hospitalization. Some other services, depending upon the patient's coverage, may also be covered. A partial listing of insurance programs accepted at Lindner Center of HOPE for hospitalization and other inpatient services are listed here. Exclusionary Criteria for Inpatient Admission

Medical Exclusions

- Third trimester pregnancy
- Primary diagnosis of severe developmental delays including mental retardation in the moderate to profound stage and Autism at levels 2 & 3
- Severe stage dementias
- Primary diagnosis of acute delirium
- Acute medical diagnosis requiring venous access, ventilation support, cardiac monitoring, or respiratory treatments (does not include inhalers)
- Acute seizure disorder (within 4-6 weeks)

Substance Abuse Exclusions

- Sole diagnosis of substance abuse/dependence including: Alcohol, Cocaine, Hallucinogens, Amphetamines, and Opiates
- Acute alcohol or benzodiazepine withdrawal requiring IV fluid support
- Blood alcohol level above 150 mg/dl. (150 mg/dl and above will be considered for potential admission as long as the patient can ambulate safely, verbalize to others, and care for personal needs)

Legal Exclusions

- Current criminal court mandated treatment or forensic treatment needs
- Registered sexual offender and/or pedophile

My Background

I have a history of mental health issues on both sides of my family and had 2 episodes of clinical depression in my twenties.

However, with the right medication and therapy I was able to thrive for 20 years.

June 2019

After my psychiatrist retired, my primary care physician began managing my meds in 2015 and this worked well until this summer. My medication was changed in June and this decision was disastrous. I began having unexplained joint pain which my doctor thought was MS. I had a number of tests but while going without an official diagnosis for 60 days, the anxiety disrupted my sleep and by October I was very sick. I lost a considerable amount of weight, had

severe anxiety, could not sleep or work and my blood pressure was very, very high. I finally had an MRI which showed that I had compressed discs in my neck causing the pain. However, no one was addressing my meds and the fact that I wasn't sleeping. Because I didn't have a psychiatrist, I wasn't able to get an appointment as a new patient with any doctor for 6-8 weeks. I knew I wouldn't make it that long if someone didn't help me. At my lowest point, I contacted the Lindner Center of HOPE (LCOH) and considered the inpatient program even though that wasn't what I needed. Your admittance nurse told me about your Rapid Access program.

That's when we met Dr. Rodriguez and everything changed for the better. He was so kind and compassionate and listened intently to my history and my husband. He put me back on the medication I had been on before June 2019 and added meds to help me sleep and for anxiety. I have been seeing him regularly and thankfully can sleep again. Dr. Rodriguez saved me.

The LCOH Rapid Access Program was a godsend for me. Having a program like this for people who don't need true inpatient care, that allows them to see a psychiatrist quickly, is so powerful. When someone needs to see a doctor, but are asked to wait 6-8 weeks for a new patient appointment, can mean the difference between life and death. And I'm not being dramatic with that statement. LCOH was my last hope for help – and my husband and I are so grateful for the care I received. A primary care physician should never administer psychiatric medications – they do not have the expertise that's needed to manage this complex disease. With Dr. Rodriguez, I have hope again that I will continue to improve every day and I am looking forward to my life returning to normal now with the care and help I received through Rapid Access and the LCOH. The care and help that so many people are missing.

Rapid Access Service

A barrier to the delivery of quality mental health care services is the lack of rapid access to service. Wait list times to see an outpatient psychiatrist for an initial session can exceed 12 weeks or more, leaving patients and families in need of treatment in urgent situations with few alternatives for care.

Lindner Center of HOPE Professional Associates Rapid Access Services (RAS) is an outpatient service for patients 18 and older open Tuesday and Thursday afternoons from 12:30 p.m. to 4 p.m. This service will enable patients in need to have a scheduled appointment, within days of the call. The appointment includes a thorough outpatient assessment with a psychiatrist and social worker, a care plan, recommendations with referrals and a written after-visit summary. In addition, when needed subsequent bridge appointments may be scheduled with the psychiatrist. RAS will enable patients to quickly get outpatient help with symptoms and concerns.

Initial Appointment, scheduled for 2.5 hours

- 45 to 60 minute visit with social worker
- 30-minute screening completion
- 45 to 60 minute meeting with psychiatrist
- Presentation of plan of care with recommendations
- After-visit summary

Fee: \$565 including deposit (A \$100 non-refundable deposit is required at the time the appointment is scheduled..)

RAS is a private-pay service and does not accept insurance.

Bridge Appointments

- Provides continuity of care
- Scheduled with psychiatrist
- Up to three may be scheduled
- Not restricted to RAS time, but rather mutually agreeable time for psychiatrist and patient
